I was captain aboard an 87 foot "Johnson" motor yacht and did an 8 week cruise/delivery with the owner and family. We cruised from Ft Lauderdale stopping in St Augustine FL, Fernandina Beach FL, Savannah GA, Hilton Head Island SC, Charleston SC, Beaufort NC, Annapolis MD, Cape May NJ, New York Harbor, Sag Harbor NY and final destination was Montauk NY.

**February 2014 to February 2016**

I have been working in Ft Lauderdale running various 100 to 150 passenger excursion vessels, Fiesta, Island Adventure and Island Discovery.

**January 2013 to January 2014**

During this time I took time to complete all course work and testing to complete all requirements for my USCG 500 Ton Master License as well as transporting various yachts north and south on the US East coast, Bahamas, and Caribbean.
